### CC-1: Military Land Use Compatibility Checklist- Beaufort County

---

**Primary responsibility:**  County  Military

#### Definition

The Coordination Checklist is a tool that helps the Beaufort County Planning Department ensure the completeness of an assessment for a project located within an area that potentially impacts a military operational area.

#### Purpose

The Compatibility Checklist helps the county community planner effectively identify planning issues and aspects that are unique to military operations in a rural context where there may be a minimal planning framework. It covers topics related to coordination with the military installation and public notification as applicable, as well as technical topics including:

- Land use – impacting military overflight areas, ground training areas, etc.
- Noise – impacting sensitive land use receptors, areas requiring noise reduction, etc.
- Vertical Obstructions – impacting pilot and citizen safety, military airspace operating areas, airfield radar systems (ARS) radar and weather radar
- Frequency Spectrum – impacting aircraft radar, ARS, weather radar and / or other electronic systems

#### Key Issues

The Compatibility Checklist is only intended as a guide. Planners using the checklist must ensure thorough coordination and communication with all potentially affected military and other organizations to ensure a complete assessment of the development / project potential impacts and identification of possible solutions.

#### Roles and Responsibilities

**Community Planner's Role.** The county community planner should assess and evaluate the proposed development / project to identify any potential impacts to military installations and / or military operating areas. By establishing lines of communication in advance with the military installation staff and other affected organizations, the planning process will proceed more efficiently with improved outcomes.

#### Implementation and Maintenance

**Implementation.** The Compatibility Checklist should be implemented as a matter of course anytime a proposed development / project is located in an area where there is a military installation and / or military operating area. Where responses to checklist items indicate the potential for incompatibility with a military installation and / or military operating area, the planner should ensure the military and other affected organization are made aware of the concern. Additional coordination and / or actions may be required to prevent any incompatible development.

**Maintenance.** The Compatibility Checklist should be reviewed periodically by the county community planner who should also coordinate with the military for any new information that should be incorporated into the checklist.

**Primary responsibility:**  City  Military

### Definition

The Coordination Checklist is a tool that helps the City of Washington Planning Department ensure the completeness of an assessment for a project located within an area that potentially impacts a military operational area.

### Purpose

The Compatibility Checklist helps the city community planner effectively identify planning issues and aspects that are unique to military operations in a rural context where there may be a minimal planning framework. It covers topics related to coordination with the military installation and public notification as applicable, as well as technical topics including:

- Land use – impacting military overflight areas, ground training areas, etc.
- Noise – impacting sensitive land use receptors, areas requiring noise reduction, etc.
- Vertical Obstructions – impacting pilot and citizen safety, military airspace operating areas, airfield radar systems (ARS) radar and weather radar
- Frequency Spectrum – impacting aircraft radar, ARS, weather radar and / or other electronic systems

### Key Issues

The Compatibility Checklist is only intended as a guide. Planners using the checklist must ensure thorough coordination and communication with all potentially affected military and other organizations to ensure a complete assessment of the development / project potential impacts and identification of possible solutions.

### Roles and Responsibilities

**Community Planner's Role.** The city community planner should assess and evaluate the proposed development / project to identify any potential impacts to military installations and / or military operating areas. By establishing lines of communication in advance with the military installation staff and other affected organizations, the planning process will proceed more efficiently with improved outcomes.

### Implementation and Maintenance

**Implementation.** The Compatibility Checklist should be implemented as a matter of course anytime a proposed development / project is located in an area where there is a military installation and / or military operating area. Where responses to checklist items indicate the potential for incompatibility with a military installation and / or military operating area, the planner should ensure the military and other affected organization are made aware of the concern. Additional coordination and / or actions may be required to prevent any incompatible development.

**Maintenance.** The Compatibility Checklist should be reviewed periodically by the city community planner who should also coordinate with the military installation for any new information that should be incorporated into the checklist.

## CC-1: Military Land Use Compatibility Checklist – Wayne County

---

**Primary responsibility:**  County  Military

### Definition

The Compatibility Checklist is a tool that helps the Wayne County Planning Department ensure the completeness of an assessment for a project located within an area that potentially impacts a military operational area.

### Purpose

The Compatibility Checklist helps the county community planner effectively identify planning issues and aspects that are unique to military operations in a rural context where there may be a minimal planning framework. It covers topics related to coordination with the military installation and public notification as applicable, as well as technical topics including:

- Land use – impacting airfield safety zones, military overflight areas, ground training areas, etc.
- Noise – impacting sensitive land use receptors, areas requiring noise reduction, etc.
- Vertical Obstructions – impacting pilot and citizen safety, airfield imaginary surfaces / military airspace operating areas, airfield radar systems (ARS) radar and weather radar
- Frequency Spectrum – impacting aircraft radar, ARS, weather radar and / or other electronic systems

### Key Issues

The Compatibility Checklist is only intended as a guide. Planners using the checklist must ensure thorough coordination and communication with all potentially affected military and other organizations to ensure a complete assessment of the development / project potential impacts and identification of possible solutions.

### Roles and Responsibilities

**Community Planner's Role.** The city community planner should assess and evaluate the proposed development / project to identify any potential impacts to military installations and / or military operating areas. By establishing lines of communication in advance with the military installation staff and other affected organizations, the planning process will proceed more efficiently with improved outcomes.

### Implementation and Maintenance

**Implementation.** The Compatibility Checklist should be implemented as a matter of course anytime a proposed development / project is located in an area where there is a military installation and / or military operating area. Where responses to checklist items indicate the potential for incompatibility with a military installation and / or military operating area, the planner should ensure the military and other affected organization are made aware of the concern. Additional coordination and / or actions may be required to prevent any incompatible development.

**Maintenance.** The Compatibility Checklist should be reviewed periodically by the city community planner who should also coordinate with the military installation for any new information that should be incorporated into the checklist.
